During agenda review a motion was made by Councilwoman Jeffers, seconded by Councilwoman Blais, (unanimous) to amend the text of section 2. of the proposed local law text as follows:

SECTION 2: REAL PROPERTY TAX EXEMPTION

Real property owned by an enrolled member of an incorporated volunteer fire company, fire department, or fire protection district, *or* such enrolled member and spouse, residing in the Town of Colonie shall be exempt from taxation *for both town tax and fire protection district tax purposes*, to the extent of 10 percent (10%) of the assessed value of such property located in the Town of Colonie, exclusive of special assessments.
